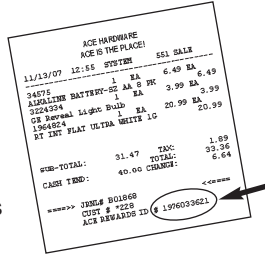


## To receive your Ace Hardware rebate, there are 2 ways to submit: E-Rebate or Mail-in. Please complete the following steps.

### 1. Was your Ace Rewards Card scanned at the time of purchase for the item(s) you want to submit an online rebate for?

Check your sales receipt to ensure your Ace Rewards ID # is printed at the bottom as shown in the sample. If your number does not appear on the receipt, **STOP**. Mail-in your rebate submission instead. If you attempt to submit online, your submission will be declined if this number does not appear on the receipt.

### 2. If your Ace Rewards number appears on your receipt, complete the following steps:
