Credit Agreement

In consideration of Allerdice Building Supply, Inc extending credit to the applicant, for purchases made by the applicant, the undersigned parties hereby agree to the following terms and conditions of credit to be extended by Allerdice Building Supply, Inc, to the applicant and the ensuing obligations of the applicant upon the extensions of such credit.

Statements on accounts are sent on the first day of each month. Payments made on or before the tenth day of the month following purchase are eligible for a ten percent (10%) discount, excluding net items, net accounts, and sale items. In any event, the applicant agrees to pay the balance of his/its account, in full no later than the end of the month in which the applicant is billed.

Any account not paid by the end of the month of billing will be considered overdue and a one and one-half percent (1.5%) finance charge per month shall be added to the account.

Payments made to past due accounts will be applied to finance charges first and then to the oldest outstanding invoices.

In the event of default, applicant agrees to pay all collection costs and reasonable attorney's fees associated with the collection of past due balances, including finance charges assessed to the account.

The applicant requests an account be opened and understands that Allerdice Building Supply, Inc may verify credit history, including, but not limited to, obtaining credit reports from reporting services and contacting credit references. Applicant acknowledges that this information will be used in determining eligibility for credit. If credit is granted, Allerdice Building Supply, Inc may contact such sources at any time thereafter in order to update credit information.

Applicant hereby authorizes Allerdice Building Supply, Inc to charge any past due balances to the credit card accounts listed in the applicants application at anytime Allerdice Building Supply, Inc determines such charge to constitute a valid remedy to avoid legal action against the applicant.

Guaranty Agreement
